

Rules of the promo campaign

'New Year Gifts Marathon by Grand Capital' (2022/2023)

1. General provisions:

- 1.1 The promo campaign 'New Year Gifts Marathon by Grand Capital' (hereinafter referred to as the 'Promo') is valid from December 12, 2022, to January 12, 2023;
- 1.2 The organizer is Grand Capital Company (hereinafter referred to as the 'Company');
- 1.3 Prize fund is distributed among the following prize categories:

- Real funds to the trading account:
 - 10 prizes of 2023 USD;
 - 20 prizes of 500 USD;
 - 100 prizes of 100 USD;
 - 200 prizes of 50 USD.

Prize funds are credited to the participant's trading account and are available for withdrawal along with profit after the trading volume is done. The trading volume is calculated according to the formula:

$$\text{Number of lots} = \text{Prize value} / 10$$

- Non-deposit bonuses:
 - 100 prizes of 1000 USD;
 - 200 prizes of 500 USD;
 - 200 prizes of 200 USD.

Prize funds are credited to the participant's trading account. Only the profit received after trading with prize funds is available for withdrawal after the trading volume is done. The trading volume is calculated according to the formula:

$$\text{Number of lots} = \text{Prize value} / 10$$

The maximum amount available for withdrawal cannot exceed the amount of the bonus received. At the first withdrawal of funds, the amount of the bonus received is debited from the trading account.

- Golden Payback account status:

1373 prizes of Golden Payback account status, entitled from the first trading day. Rules of the Payback programme are listed on the Company website: <https://grandcapital.net/trading/payback/> .

2. Who can participate:

- 2.1 All clients, who have successfully passed verification, are allowed to participate in the Promo.

3. How to participate:

- 3.1 To take part in the Promo, a participant must deposit any of his/her trading accounts at least once;
- 3.2 The minimum deposit amount must be no less than 300 USD;
- 3.3 The client must ensure relevant contact details stated in the Private Office;
- 3.4 To join the promo, the client must push the 'Take Part' button on the Company's «Promotions and Bonuses» webpage: <https://grandcapital.net/trading/bonus/> ;
- 3.5 After successful registration, the participant's account is entered in the register of accounts eligible to participate in the Promo;
- 3.6 Registration for participants is open during the entire period of the Promo from 10:00 (GMT) on December 12, 2022, to 10:00 (GMT) on January 12, 2023.

4. Giveaway:

- 4.1 The winners of the Promo will be selected with a random number generator at 13:00 (GMT) on January 16, 2023;
- 4.2 Prizes will be deposited into Standard and Swap Free types of trading accounts, with leverage up to 1:100, and no other bonus funds received from any other company promos will be deposited into these accounts;
- 4.3 Trading accounts, into which the prize funds will be deposited, are excluded from participation in any other company promos until the full withdrawal or write-off of the above-mentioned prize funds.

5. Final provisions:

- 5.1 The company has the right to use any information about the winners (except for full names, account numbers, and contact details) for the purpose of advertising in any media and social networks without the prior consent of the client;
