## TRADE LIKE A CHAMPION TRADING COMPETITION

### Terms & Conditions

1. Subject to the Trade Like a Champion Trading Competition Terms and Conditions (the “**Competition Terms**”) and **easyMarkets**<sup>1</sup> business terms and policies set forth on the easyMarkets Legal Page, clients that meet the criteria of the Competition Terms set forth hereinafter will be eligible for the Trade Like a Champion Trading Competition (the “**Competition**”) as defined below.

- b. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the “Competition ”; without limiting the foregoing, participation in the “Competition ” is not allowed for persons under the age of 18.<sup>2</sup>
- c.
