

# “Non-Deposit Bonus” Term & Conditions

The “Non-Deposit Bonus” (“Promotion”) is available to all **New Introducer Broker** client with “Avant-Markets” who open a live trading account under the network of **Danialmalekdash@gmail.com** from 23<sup>rd</sup> June 2022 to 31<sup>st</sup> July 2022. The bonus amount will be added as “Credit Bonus” to the account and will last for 1 calendar month from promotion the date.

## 1) Participants

- a) All clients under the network of **Danialmalekdash@gmail.com** network.

## 2) Duration

- a) The promotion duration (“Promotion Period”) is 1 month from **June 23<sup>rd</sup>, 2022** until **July 31<sup>st</sup>, 2022**.
- b) The duration of the credit bonus (“Credit Bonus Period”) will be **1 month** from the date of promotion.

## 3) Promotion Application

- a) To participate in this Promotion, the participants must directly contact any Avant-Markets Representatives either by email or phone.
- b) Participant can also contact Avant-Markets Support Team through our official email or via Live Chat.
- c) Non-Deposit Bonus may take up to **48 Hours** working days to be credited into MT4 trading account.

## 4) Conditions

- a) This Promotion only valid for Avant-Markets STP Account (“Trading Account”) only. This promotion is not valid for any other trading accounts including the Copy Trading account.
- b) Client must complete his registration under the network of **Danialmalekdash@gmail.com** to eligible for this Promotion.
- c) Internal transfer is not eligible for the Promotion.
- d) Leverage of the Trading Account will follow the condition set by the Leverage Terms & Conditions.

## 5) Mechanic of the Promotion

- a) Participant will receive **\$50 credited** into the Trading Account, only when registered under the network of **Danialmalekdash@gmail.com** registration link.
- b) Participant can only claim **once** throughout the promotion period.
- c) The Credit Bonus is not cashable, but it is losable.

- d) Participant may make a withdrawal from his Promotion Account only when he achieved accumulative of **5.0 trading lot effective standard FX**.
- e) Effective lot mean the position need to be float more than two (2) minutes before close.
- f) Upon achieved the withdrawal requirement, participants may transfer or/and withdraw a minimum profit of **\$50** and maximum of **\$150** from the promotion trading account upon request.

- c) Any indication or suspicion, in Avant-Markets' sole discretion, of any form of arbitrage (including but not limited to risk-free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially from the Bonus without being genuinely interested in trading in the markets and/or taking market risk), fraud, manipulation, cash-back arbitrage connected to a Bonus or any other forms of deceitful or fraudulent activity, will nullify all previously credited bonuses of the eligible client's real trading accounts with Avant-Markets and/or any transactions carried and/or profits or losses garnered therein.
