



TERMS \$ CONDITIONS

30 % TIOx BONUS

The TIOx BONUS of up to 30% (the “Promotion”) is applicable to any TIOmarkets or TIOprime client who purchases the minimum sum of 15,000 TIOx via the client portal, during the promotional period.

This promotion will automatically renew on the first day of each calendar month up until such time as the company sees fit to terminate. TIOmarkets reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel or terminate the Promotion, or any aspect of the Promotion, at any time and without any prior notice.

For the bonus up to 30% to be applied, the TIOx need to be deposited into a TIOmarkets Signature account. Once this occurs, we will process the deposit of up to an additional 30% non-withdrawable TIOx into the client account.

Minimum TIOx purchase to qualify for this promotion is 15,000 TIOx.

New and existing clients qualify for this promotion, and they may benefit from this promotion multiple times throughout the duration of the promotional period, up to a maximum value stipulated below.

The maximum amount that can be allocated in bonus funds to any trader over the lifetime of the promotional period is 100,000 TIOx.

TIOx purchased from IDEX or MERCATOX qualify for this promo.

TIOx purchased via the TIOprime/tiomarkets portal PURCHASE NOW button do not qualify for this promo.

The client can trade using the TIOx bonus however, cannot withdraw them or exchange them or lock them into the TIOprime Pool.

Any TIOx that were purchased prior to this promotion, do not qualify for this promotion.

Trading credit will be applied to the client Signature account according to the following tiers

Clients will not be eligible to place any bonus funds into the Liquidity Pool.

Only traders with the TIOmarkets Signature account type qualify for this promotion. Standard, VIP, VIP Black, Demo or PAMM account types do not qualify.

Any clients registered under our FCA regulated entity TIO Markets Ltd UK, do not qualify for this promotion.

The bonus will be calculated at the time of processing the client deposit request. The funds will be credited to the client's Signature account within one business day.

Introducing Brokers (IBs) of TIOmarkets may participate in this Promotion.

Any changes shall be at the discretion of TIOmarkets without any prior notice.

TIOmarkets has the right to withdraw without prior notice the Promotion or profit gained if: a) a breach of these Terms and Conditions occurs; b) Upon expiration of the Promotion, the trading terms are not satisfied; c) The Company has reasonable grounds to believe a misuse of the Promotion; d) Client attempts to withdraw any part of the Promotion before satisfying the Trading Terms. e) TIOmarkets has reasonable suspicion that the Client has already or intends to take advantage of the Promotion.

TIOmarkets will not be liable for any margin call or losses that you may suffer, including but not limited to losses due to Stop-out Level.

Under no circumstances shall TIOmarkets be liable for any consequences of any alteration, amendment, suspension, cancelation or termination of the Promotion.

Any indication or suspicion of fraud, manipulation, cash-back arbitrage, or other forms of deceitful or fraudulent activity in a client's account with TIOmarkets or otherwise related or connected to the Promotion will nullify any and all transactions carried and/or profits or losses garnered therein.
