TERMS AND CONDITIONS

This offer only applies for selected regions as stated in Company website and other Company owned informative channels and for as long as the Company deems to provide it.

2. Qualification period of the promotion is from 00:00 22nd of August 2022 till 23:59 22nd of November 2022, MT4 trading server time. Only trading operations from verified accounts during this period will be counted for the contest. Only one client from the same address is eligible for this promotion.

3. To qualify, a minimum of 500 normal lots should be traded at the end of the campaign period; it also can be utilized along with any ongoing promotion except NDB.

4. Only closed orders can qualify for the number of trades. Pending orders and hedging trades will not be qualified for the volume calculations. Traded volume will be calculated from all the available trading instruments.

5. AximTrade reserves the right to provide clients with an alternative prize (cash and/or item) that it deems fit, to the prize winners.

6. Clients (both parties) who accessed another client's trading terminal from the same device or IP address with the master password will be disqualified for this promotion.

7. Clients are not allowed to provide access to the trading account through trading passwords to any other user. Clients who are sharing the same bank account for deposit/withdrawal operation or are doing any other form of activity where there is only one final beneficiary of the trading results and/or rebates - will be disqualified from the promotion and trading results and rebates will also be canceled. Scalping is considered a serious breach of our Terms and Conditions, and as such, AximTrade may in its absolute discretion close out, replace, reverse any Transactions or close out the Account with immediate effect. Any indication or suspicion, in AximTrade's sole discretion, of any form of arbitrage (including but not limited to risk-free profiting), abuse (including but not limited to participant's trading activity patterns that indicate that the participant solely aims to benefit financially without being genuinely interested in trading in the markets and/or taking market risk; or trading activity where the majority of trades are reopened in the same trading instrument less than 30 seconds after the trade in the same direction was closed), keeping account completely hedged more than 50% of the trading time, internal hedging in coordination with other parties or any other form of hedging with the attempt to abusive trading intentions, abuse of our 'negative balance protection', fraud, manipulation, cash-back arbitrage or any other forms of deceitful or fraudulent activity, will constitute all Transactions carried and/or profits or losses garnered as invalid. In these circumstances, we reserve the right to close/suspend (either temporarily or permanently) all the Client's trading Accounts and/or cancel all trades. In view of the above, please note that you will be strictly prohibited from opening any new trading Account(s) and trade with AximTrade.

8. AximTrade preserves the right to disqualify accounts from the promotion if the client is making any type of risk-free profiting based exclusively on the utilization of any technical issue on the AximTrade system.
