

DEPOSIT BONUS (100% / 200%)

Introduction

A.

1. TTCM Traders Capital Limited (hereinafter called "Company", "Traders Trust") a limited liability

Company, incorporated in Bermuda under section 14 of the Companies Act 1981 and registered with the Registrar of Companies under Company number 54135, with registered address 5th Floor, Andrew's Place, 51 Church Street, Hamilton HM 12, Bermuda.

6. The conversion ratio is 1 closed lot round turn for \$5 credit value, therefore if the Deposit Bonus is \$1,000 the minimum of 200 closed lots will be required within 90 days.

7. If a participant has deposited several times more than \$1000, receiving multiple Deposit Bonuses in the same account, then the lot requirements for all received bonuses must be covered.

8. The participant needs to trade the total volume required if he wants to transfer the Deposit Bonus to balance or withdraw it.

If there is any conflict or inconsistency between the English version and the translated version of the Terms and Conditions, English will be the prevailing and predominant version.
15. The Company reserves the right to disqualify any participant for suspected violation of the Terms and Conditions of the Deposit Bonus.
16. The Company reserves the right to change the Terms of the Campaign or cancel it at any time.
