1. Introduction

1.1. ABX Trade LLC ("the Company") is a limited liability company incorporated under the laws of St. Vincent and the Grenadines, with Company No: 2004 LLC 2022 and has its registered office at the First Floor, First St. Vincent Bank Ltd Building, James Street, Kings-town, St. Vincent, and the Grenadines.

The company provides online platforms for clients to trade over-the-counter (OTC) derivatives, including margin foreign exchange ("Forex") contracts and contracts-for-difference ("CFDs"). The company's online platforms operate through the www.abxtrade.com website ("Website").

1.2. The terms and conditions of the "Welcome Bonus USD 30", later referred as WBUSD30 are an integral part of the "ABX Trade Terms of Business" and the provisions set out herein are regarded as an appendix to all " ABX Trade Terms of Business."

2. Conditions of Eligibility

2.1. Subject to and without prejudice to all other Business Terms and Policies, the Offer shall be made available to client of the Company who have met the Eligibility Criteria for the Offer ('Eligible Client') as set out in the following sections.

2.2. Company may offer the WBUSD30 to client who open real trading accounts (WELCOME BONUS Account), where such client is referred to the Company through specific websites and/or social network sites in the context of specific promotions and/or surveys conducted by the Company.

2.3. The Company offers the WBUSD30 to any Client(s) and/or any country/region as it deems appropriate and for as long as the Company considers it to be provided, at its absolute discretion.

2.5. The WBUSD30 may be used only by persons who may enter into legally binding contracts under the laws applicable in their country of residence. Without limiting the foregoing, participation in the WBUSD30 is not permitted for persons above the age of 65 or otherwise over the legal age in their country of residence ('elderly'). You may not participate in the WBUSD30 if you are an elderly.

2.6. Participation in the WBUSD30 of "Intermediaries / Related Parties" is prohibited. Where the registration and/or trading information of a participant in the WBUSD30 corresponds to the registration and/or trading information of another participant in the WBUSD30 including but not limited to the IP address, the Company reserves the right to regard that matching as an immediate reason for disqualification. For these Terms and Conditions, the term 'Intermediary(ies)/Related Party(ies)' means, when used in these Terms and Conditions, to include, without limitation, any person or entity having a relationship with any participant in the WBUSD30, including:

- family members, such as brothers, sisters, spouses, ancestors, lineal descendants, and collateral descendants;
- person or entity to whom any participant in the WBUSD30 controls, directly or indirectly through one or more intermediaries, any participant in the WBUSD30 controls, or who, for this definition, is under common control with any participant in the WBUSD30; for this definition, the term "control" (including, with co-intermediaries), possession, directly or indirectly through one or more intermediaries, of the power to direct or guide the management policies of that person or entity, whether through the ownership of voting securities or otherwise, shall be understood as such.
- Similarly, individuals associated in any way with the Company and/or with specific websites and/or social network sites on which the Company may run specific promotions, contests, and/or surveys from time to time, in which access to the WBUSD30 is provided, are not permitted to participate in the offer.

3. Specific WBUSD30 Terms

3.1. Eligible Clients, who meet the criteria set forth herein can receive trading bonuses equal to:

3.7. Withdrawal process may take up to 2-5 business day to be completed. The trading account will be disabled after the withdrawal process is made or the campaign period has ended.

4.2. The WBUSD30 applies to all client who, by the rules set out herein, open a real account with the Company and awarded bonuses may be used for trading purposes only.

4.3. Any withdrawal of funds from the actual account(s) of an Eligible Client with the Company will cause the remaining bonus & balance to be forfeited.

4.4. In the case of internal transfers between the company's trading accounts, the trading bonuses previously credited to the sending account will be removed completely as well.

4.5. The Company reserves the right, at its reasonable discretion:

- The refusal of any participant in the WBUSD30 to be registered; and

Client will be given prior notice of such modifications and the Company will post any such modifications on its website. Participants in the WBUSD30 are recommended to regularly consult these Terms & Conditions on the Company's website. Please note that participation in the WBUSD30 constitutes acceptance of, and agreement to comply with, any such changes, changes, and/or modifications.

4.9.
