

## Terms & Conditions Partner Loyalty Program

1. 2. The promotion is available to IBs or Partners and is determined by net deposits and new funded client registrations exclusively from direct clients. For the purposes of this document, "direct clients" are defined as clients directly referred by an IB or Partner.
3. The net deposits considered for this promotion will be calculated as follows (total deposit transactions - total withdrawal transactions) for the respective month. This will include any deposit or withdraw transaction made from a wallet (not an IB wallet). Withdrawal transactions made from an IB wallet will not be included in the net deposit calculation.
4. The number of new funded clients calculated for the promotion, will include only new clients who make their first initial deposit during the respective month.
5. Clients whose individual deposits represent more than 20% of the Partner's monthly net deposit will be excluded from the promotion calculation.
6. Partners who have a minimum of 5 new funded clients and a minimum net deposit of 25,000 USD or more during the respective month will be eligible to receive rewards.
