

No Deposit Bonus Terms and Conditions

Eligibility

This introductory "No Deposit Bonus" may be availed of by any Philippine individual who is not an existing client of VIPGlobal Capital. For existing clients who wish to avail of bonus programs, please refer to our other promotions open to you.

Registration and \$50

In order to participate in the "No Deposit Bonus" promotional offer, individuals need to register with our client portal. After this, open a Standard Live Account and email marketing@vipglobalcapital.com with your account details in order to get the \$50 trading margin.

Standard Account Only

The promotional offer is applicable only to the Standard Account type provided by the platform. Other account types, such as Pro or VIP accounts, may not be eligible for this particular promotion.

AML and Withdrawal

For AML purposes, withdrawals of trading profits can only be processed if an individual has completed their KYC (Know Your Customer) documentation. This will involve providing a Valid ID* and Proof of Address**.

Minimum and Maximum Withdrawable Amount

To be eligible to withdraw any profits generated from the No Deposit Bonus, a minimum profit of \$50 must be achieved. However, the maximum amount that can be withdrawn is capped at \$100. This means that even if the profit exceeds \$100, the cumulative withdrawal will only be processed up to the maximum allowed.

Minimum 10 Round Turns

Before initiating a withdrawal request, traders must complete a minimum of 10 round turns. A round turn refers to opening and closing a position. This requirement ensures that traders engage in a certain level of trading activity before accessing the withdrawal option.

Cumulative 10 Lots

In addition to the round turn requirement, traders need to accumulate a total trading volume of 10 lots. A lot represents a standardized trading contract volume. Please check Symbol properties on specification for further details on the lot size of the instrument you are trading.

Transfer To Wallet

The Principal Amount and Profits cannot be transferred to the client wallet. All promo-related withdrawals shall be requested through support@vipglobalcapital.com and credited only to the account of the person registered in the Client Portal.

No System Gaming

To maintain the integrity of the promotional offer, the platform monitors and prohibits any attempt to manipulate the system such as, but not limited to, hedging different accounts and using professional trading services, among others.

Manual Trading Only, No Copy Trade or Social Trading

Traders participating in this promotional offer are limited to manual trading only. Copy trading or social trading, where traders automatically replicate the trades of other successful traders, are not allowed within the scope of this offer.

Valid for 1 Month Only

No Deposit Bonus accounts will be available for trading for a period of 1 month, after which trading will be disabled. All profits eligible for withdrawal should be withdrawn by the customer within a period of 1 month.

*Valid ID is defined as any form of identification issued by a government agency.

**Proof of Address could be any form of billing or binding contract stating the name and address of the participant or certification of their address by a government agency.
