TERMS AND CONDITIONS

## Campaign Period

01 November 2024 – 31 December 2024

## Introduction of Organizer

1. Lirunex Limited (Registration No.: 102684) is registered under the Republic of Marshall Islands law under license with Certificate No. FC00022020 (hereinafter known as the “Company”), runs **Christmas Mystery Treasure Box** (hereinafter known as the “Contest”).
2. The Contest runs from **01 November (00:01 Server Time)** to **31 December 2024 (23:59 Server Time)**, inclusive of both dates.

## Instructions for enrolment

3. The Contest enrolment must be made by submitting the **Application Form**.
4. Clients need to ensure all the information submitted for enrolment is true and correct.

## Contest Criteria

5. The Contest is applicable only for the following account types (**LX-Standard, Islamic Standard, LX-Prime, Islamic Prime, Standard Plus Swap Free, LX-Cent or LX-Cent Swap Free**). *\*Markups available*
6. All trading account(s) must be created from the account of the Company portal known as the Company Traders Room.
7. This Contest is open to all entrants who:
  - i) are 18 years of age or above;
  - ii) deem to comply with these terms and conditions; and
  - iii) are not management, employees, or Promoter agents or its related entities (or immediate family members of such people) (“Eligible Entrant”).
8. The following categories of accounts are **NOT ELIGIBLE** to participate in this Contest:
  - i) Managed funds master/investor trading account(s) of any account type.
  - ii) Copy Trade master/investor trading account(s) of any account type.
  - iii) Elite Trading account(s) of any account type.
  - iv) Demo account(s) of any account type.
9. This Contest is valid for Lirunex Limited cust omers with **Newly Created** active MT4/MT5 accounts on the Lirunex Limited MT4/MT5 server.
10. Participants are **NOT Allowed** to use the same account to participate in other bonus promotions/contests in Lirunex Limited.
11. The Contest is eligible only for **New** deposits from the wallet to MT4/MT5 accounts within the stipulated Contest period. Internal transfers of funds between MT4/MT5 accounts will **NOT** be construed as a deposit and will render the contestant ineligible for participation and subsequently disqualified from the Contest.

  - ii) **Min. Traded Lots:** Accumulation of total Closed Trades traded lot size(s) performed within the Promotion period, accounted from the Date and Time of successful enrollment.

Any trade(s) that are not closed by end of the contest period two months will be automatically excluded from the calculations of criteria achievements stated in *Table 1*.
16. Every prize tier is limited to a certain number of pax. Suppose eligible participants exceed more than the given pax. In that case, the eligible participant(s) will be decided based on the highest number of trading lot sizes achieved on the trading account - on a **first-come, first-served** basis (subject to availability).
