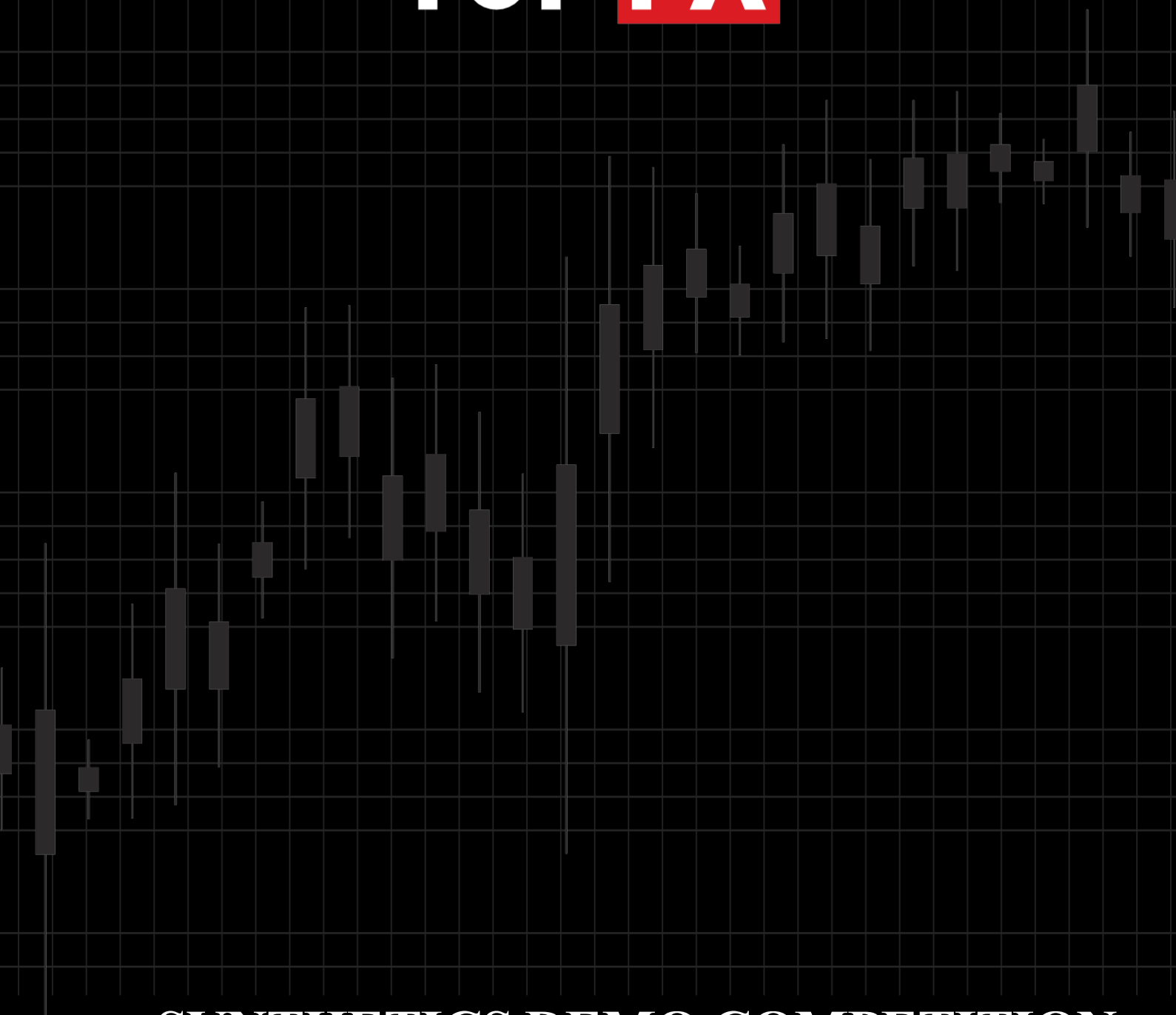

## SYNTHETICS DEMO COMPETITION

### TERMS AND CONDITIONS

#### A. Introduction

1. TopFX Markets Ltd (hereinafter the “**Company**” or “**TopFX**”) is a company registered under the Laws of British Virgin Islands (BVI) with registration number 2116078 and is licensed by the Financial Services Commission (FSC) in BVI with License Number SIBA/L/23/1161.
2. The Synthetics Demo Competition (“**Competition**”) Terms and Conditions (“**Terms & Conditions**” or “**T&Cs**”) is an integral part of the TopFX Terms of Business (available at [https://topfx.com/bvi/pdfs/Terms\\_and\\_Conditions.pdf](https://topfx.com/bvi/pdfs/Terms_and_Conditions.pdf)) and provisions set herein are considered as an Annex of these terms. Capitalized terms used herein without definition shall have the meanings assigned to them in the TopFX Terms of Business.

#### B. General Provisions

1. Subject to and without prejudice to all other Terms of Business of the Company, this Competition is available to all TopFX clients who satisfy the criteria for the Competition (“**Eligible Clients**”) set herein.
2. The Competition will be valid from 12<sup>th</sup> of November 2025 – 1<sup>st</sup> of January 2026 (both days inclusive) (“**Competition Period**”).
3. Subject to Section B.2. above, the Competition is available to all existing and new clients of TopFX who during the Competition Period:
  - Have at least one (1) verified TopFX Demo cTrader trading account; and
  - Trade at least one (1) trade on **all** Synthetic Indices available on the cTrader platform (i.e. need to place at least one trade on each Synthetic Index).
4. Registration for the Competition can be achieved through the official website of TopFX or through the clients’ Members Area.
5. Upon registration, each participant must select a deposit amount of 10,000 USD when opening their cTrader Demo Account in order to participate in trading Synthetic Indices. Participants who open a cTrader demo account with any deposit amount other than 10,000 USD will not be eligible for the Competition.
6. Each participant agrees that by registering to the Competition express their free, prior and informed consent for the Company to process any personal data which they provide while registering. The data is collected and processed only to such extent which is necessary to administer and run the Competition.
7. Participating in the Competition is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence.
8. The Competition is not available to people associated in any manner with TopFX.

### C. Specific Competition Terms

1. Eligible Clients who meet the eligibility conditions set in Section B above as well as the eligibility and participation requirements set herein will get the chance to win the prizes described in Tables A and B below.
2. In case any of the winners of the cash balance does not have a live trading account with the Company he/she will need to register a real trading account with TopFX in order to claim the cash prize. In case that any winner does not wish to open a real trading account with the Company then the prize awarded will be awarded to another Eligible Client following the same procedure. That is if the prize was awarded based on performance then the prize will be awarded to the next Eligible Client based on performance.
3. The cash balance award is withdrawable.
4. By accepting the terms and conditions of the Competition, the winners who will win the prizes described herein agree that TopFX has the right to use their name and/or nickname, trading statistics and performance summaries for publication purposes on TopFX official website.

### D) Overall Prizes

1. The Company will award the Clients with the highest Return on Investment (ROI) during the Competition Period with the prizes described in Table A below.

2. The calculation of the ROI will take place after the end of the Competition Period.
3. In case that two (2) or more clients have the same score a lucky draw between them will be conducted for awarding the prize.
4. The winners will be announced after the end of the Competition Period.

II) Periodic Leaderboard Milestones Prizes

1. Eligible Clients who satisfy the eligibility and participation requirements set herein will be able to win one of Leaderboard Milestones prizes as these are described in Table B below.

2. The Periodic Leaderboard milestone prizes will be awarded to four (4) winners in total.
3. One (1) winner will be announced every ten (10) days.
4. The three (3) winners will be announced during the Competition Period whereas the 4<sup>th</sup> winner will be announced after the end of the Competition Period.

## **D) Reservation of Rights and Disqualifications**

1. Clients who provided incorrect or fraudulent information during the demo account registration will be disqualified from participating in the Competition.
2. The Company reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel or terminate the Competition, or any aspect of the Competition, at any time. Under no circumstances shall the Company be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Competition.
3. Any indication or suspicion of fraud, manipulation, cash-back arbitrage, or other forms of deceitful or fraudulent activity in a client's account or multiple accounts with the Company or otherwise related or connected to the Bonus will nullify any and all transactions carried and/or profits or losses garnered therein. The Company reserves the right, at its sole discretion, to disqualify any individual that misuses or attempts to misuse the Competition or breaches the present T&Cs and/or any of Business Terms and to cancel all orders and annul all profits of such client. In these circumstances, The Company shall not be liable for any consequences of the Competition cancelation.
4. Clients, who have abused or suspected to have abused any previous promotions, acted in bad faith, or submitted false or inaccurate information upon their registration at any point in the past, or have been found in any way to not uphold with the T&Cs set by the Company or act or acted in any other abusive manner are not considered to be eligible.
5. The Company may terminate this Competition immediately without giving notice and the Company has the right to reverse and/or cancel all previous transactions on a Client's account, if the Company reasonably suspects that the Client logs-in to his/her Trading Account(s) and/or trades under the same device and/or under the same IP address as other Client(s) who performed or performs abusive trading and/or is suspected that the Client trades in cooperation with another Client(s) and where the Client and other Client(s) use the same or similar trading patterns. This also includes usage of Virtual Private Networks (VPN)/ Virtual Private Server (VPS).
6. Eligible Clients who have been disqualified lose their right to claim the prize offered.
7. In the event of any dispute or misinterpretation of the above applicable T&Cs, such disputes or misinterpretation shall be resolved as the Company acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. The Company's decision shall be final and binding.
