4XC 8TH ANNIVERSARY CELEBRATION 75% FIRST DEPOSIT BONUS TERMS & CONDITIONS

1. General Terms

This Addendum temporarily modifies certain clauses of the First Deposit Bonus Terms and Conditions for the duration of the **4XC 8th Anniversary Celebration – 75% FIRST DEPOSIT BONUS**.

- 1.1 The “4XC 8th Anniversary Celebration – 75% FIRST DEPOSIT BONUS” (hereinafter “Promotion”) is a limited-time campaign offered at the sole discretion of 4xCube Ltd (“4XC”).
- 1.2 This Promotion will be available from **1 July 2026 until 30 September 2026** (inclusive, MT4/MT5 Server time).
- 1.3 Each client may claim the **4XC 8th Anniversary Celebration – 75% FIRST DEPOSIT BONUS** only once during the Promotional Period. Once the Bonus has been granted under this Promotion, the client cannot claim an additional First Deposit Bonus after the Promotion ends, unless otherwise specified under future promotional programs.
- 1.4 The Promotion is available to both new and existing clients who make a deposit into an MT4/MT5 trading account during the Promotional Period. This Promotion does not apply to Investment accounts or PAMM accounts.
- 1.5 Existing clients must make their qualifying deposit within the Promotional Period in order to participate.
- 1.6 Clients who have previously received a First Deposit Bonus may receive it again under this Promotion, provided that any previously awarded First Deposit Bonus has been cancelled. If the previous Bonus has not yet been removed, the client must request its cancellation by contacting support@4xc.com before becoming eligible for the new Bonus.
- 1.7 Clients who have previously received the First Deposit Bonus may not receive the **4XC 8th Anniversary Celebration – 75% FIRST DEPOSIT BONUS** on the same trading account. To become eligible for this Bonus, the previously awarded First Deposit Bonus must first be cancelled in full. Once the cancellation has been completed, the client must open a new MT4 or MT5 trading account, make a qualifying deposit into that account, and submit a request for the Bonus in accordance with this Addendum. For the avoidance of doubt, the First Deposit Bonus and the 4XC 8th Anniversary Celebration – 75% FIRST DEPOSIT BONUS cannot, under any circumstances, be active simultaneously, whether on the same trading account or across multiple accounts held by the same client.
- 1.8 The Bonus is available only for deposits made directly into the trading account. Internal transfers, IB commission payouts, and any other non-deposit transactions do not qualify for the Bonus.

- 1.9 The Bonus is equal to 75% of the first qualifying deposit made into the eligible MT4 or MT5 trading account during the Promotional Period, up to a maximum bonus amount of **2,000 USD/EUR/GBP or 10,000 BRL**.
- 1.10 The minimum deposit required to qualify for the Bonus is **100 USD/EUR/GBP or 500 BRL**.
- 1.11 Clients from Indonesia, Pakistan, Vietnam, Egypt, Malaysia, and the United Arab Emirates (UAE) are eligible for a maximum First Deposit Bonus of up to 20% of their first qualifying deposit made into the eligible MT4 or MT5 trading account during the Promotional Period, capped at the maximum bonus amounts stated above.
- 1.12 The First Deposit Bonus is not available to clients from Bangladesh, Turkey, Nigeria, China, Hong Kong, Kenya, Chad, Sudan, Niger, Cameroon, Burkina Faso, and the United Republic of Tanzania.
- 1.13 After the promotional period, the standard First Deposit Bonus offer will resume (50% FDB, capped at 1,000 USD/EUR/GBP or 5,000 BRL).
- 1.14 All other Terms and Conditions of the First Deposit Bonus not specifically modified in this Addendum remain in full force and effect, as outlined in the official First Deposit Bonus Terms and Conditions available [here](#).

2. General Eligibility

- 2.1 The Promotion is open only to verified clients of 4XC who have successfully completed all internal compliance and KYC procedures in accordance with regulatory requirements.
- 2.2 To be eligible to receive the Bonus, the client must:
- Complete the full KYC verification process;
 - Fund their MT4 or MT5 trading account; and
 - Submit the [First Deposit Bonus \(FDB\) request form](#) available on the 4XC website.

Upon verification by 4XC that all eligibility criteria have been met, the Bonus shall be credited to the specified trading account within 24 business hours.

- 2.3 4XC reserves the right, at its sole discretion, to decline participation or remove Bonus benefits from any client without prior notice.

3. Abuse and Misconduct

- 3.1 If 4XC suspects that a client has abused, attempted to abuse, or acted in bad faith regarding this Promotion, 4XC reserves the right to deny, cancel, or withdraw any associated benefits and/or terminate the client's access to 4XC services.
- 3.2 Abuse includes, but is not limited to, bonus manipulation, coordinated trading strategies between multiple accounts, or exploitation of pricing or platform anomalies.
- 3.3 In cases of verified abuse or manipulation, 4XC reserves the right to void profits, remove bonuses, and close affected accounts.
