

Headway New Year 2026 Contest



1. General Overview

- 1.1. The "New Year 2026" Promotion (hereinafter referred to as the "Promotion") is organized by Headway and shall be conducted from **December 15, 2025, 11:00, until January 16, 2026, 23:59** (MetaTrader server time – GMT+2).
- 1.2. The Promotion aims to celebrate the upcoming New Year 2026. Clients can win from a pool of valuable prizes by trading and completing tasks to earn tickets. Each ticket provides one entry into the prize raffle.
- 1.3. The prize raffle will be held on **January 22, 2026**. The link to the livestream of the raffle will be published on the promotion page.
- 1.4. In addition to tickets, clients can participate in the "Decorate your Christmas Tree" Mini-game (hereinafter referred to as the "Mini-game") and compete for a separate prize.
- 1.5. By participating, Clients agree to these Terms and Conditions and to the General Client Agreement.
- 1.6. By participating in the Contest, Clients also agree to comply with the Company's Client Agreement available on the Company's website (<https://hw.online/> or any other official domain).

2. Participation in the Contest

- 2.1. Clients must click the "Join" button in the Application or Web version of Headway's Personal Area on the Promotion page to start accumulating tickets.
- 2.2. If the Client is using a mobile app, they must update to the latest version to see the Promotion.

3. Participation in the Mini-game

- 3.1. The Mini-Game is held as part of the main Promotion. It will be active from **December 15, 2025, at 11:00 until January 16, 2026, at 23:59**. All times are based on the MetaTrader server time (GMT+2).
- 3.2. To participate in the Mini-game, the Client shall join the Promotion as described in section 2 hereof and use the button "Decorate" on the Promotion page in Personal Area.
- 3.3. The objective of the Mini-game is to decorate a digital Christmas tree using ornaments purchased from the in-game Store. All purchases within the Store are made using the official in-game currency, "coins" (see section 4).
- 3.4. The Store consists of three (3) distinct levels. These levels are unlocked when the Client achieves the following trading volumes:
 - Level 1 – 0 lots
 - Level 2 – 1.5 lots
 - Level 3 – 3.5 lots
- 3.5. Each newly unlocked level provides access to an expanded selection of ornaments.
- 3.6. A "Top 10" leaderboard ranking participants by the total value of decorations is displayed in the Top 10 on the Promotion page in Personal Area. The value is calculated based on the cumulative "coin" cost of all placed decorations. The leaderboard ranking is for display only and does not determine or guarantee the winner.
- 3.7. For a decoration's value to contribute to the Client's final score, it must be actively placed on the digital tree. Decorations that remain in the Client's inventory will not be counted.
- 3.8. The final winner of the Mini-Game will be selected manually by the Headway team at its sole and absolute discretion from the pool of eligible participants.
- 3.9. The winner of the Mini-Game will receive one (1) physical Christmas tree with decorations, provided by Headway. Headway will arrange for the prize to be delivered to the winner by December 25, 2026.

4. Ticket and Coins Accumulation Rules

- 4.1. Clients can accumulate tickets and coins through all available methods: trading activity, Partner referrals, and task completion. Tickets earned from all sources are combined, regardless of whether the Client participates as a Trader, a Partner, or both. This means every eligible action contributes to the Client's total number of entries in the prize raffle.
 - 4.1.1. Traders
 - 4.1.1.1. **0.05 standard lot = 1 ticket, 10 coins.**
 - 4.1.1.2. Partial lots accumulate.
 - 4.1.1.3. Completing designated tasks grants additional tickets and coins. Each task may only be completed once during the Promotion.
 - 4.1.2. Partners
 - 4.1.2.1. Available after the client joins the IB program.
 - 4.1.2.2. Partner receives **1 ticket and 50 coins** when their direct-referred client closes their first-ever **0.05 lot** (lifetime), regardless of when the client was registered, as long as the 0.05 lot is closed after the Partner has joined the Promotion.
 - 4.1.2.3. Every additional **0.5 lot** traded by all direct clients combined = **1 ticket, 10 coins.**
- 4.2. Tickets and coins are customer rewards and do not constitute a financial obligation or liability of the Company. The Company reserves the right to cancel, deduct, or void any or all tickets and coins from the Client's balance at any time and at its sole discretion, without prior notice or explanation.

5. Lot Calculation Rules

- 5.1. 1 lot on a Cent account is equivalent to 0.01 lot on a Standard or Pro account.
- 5.2. For Stocks, Crypto, Indexes, Energies, and other index instruments, if the cost of 1 lot is less than 100,000 USD, the lot calculation formula is: $1 \text{ lot} * \text{Contract size} * \text{Price in USD} / 100,000$
- 5.3. When closing positions using the "Close by" function, the trading volume is calculated as half of the volume of each closed position.

5. Available Tasks

- 5.1. Tasks are available to clients in both the Trader and Partner categories.
- 5.2. List of tasks:

- 5.3. Tasks must be completed after joining the Promotion and before the Promotion ends (see section 1).
- 5.4. The Company reserves the right to disable tasks for any user in the event of abuse, spam, or submission of fake proofs.
- 5.5. The Company also reserves the right to disable tasks in case of mass fraud attempts.

6. Prize Raffle and Rewards

- 6.1. The prize raffle will be conducted via a lottery machine and randomizer during a live stream on January 22, 2026.
- 6.2. Each ticket equals one entry into the raffle. More tickets mean higher chances of winning.
- 6.3. The same Client can win multiple prizes.
- 6.4. The list of available prizes is published on the Promotion page. Prizes are subject to change based on availability, delivery possibilities to specific countries, and at the Company's discretion.
- 6.5. Prizes can be withdrawn after successful verification. The Company reserves the right to substitute a physical prize with a cash equivalent if delivery to the winner's address is not possible.
- 6.6. If a Client wins a prize, a Company representative will contact the Client via an official Company email. If the Client does not respond within two (2) weeks, the prize may be canceled.

7. Compliance and Fraud Prevention

- 7.1. Violation of the Client Agreement, fraudulent activities, or abuse of the Promotion will result in disqualification.
- 7.2. Tasks requiring manual validation may be rejected if improperly completed. Clients may resubmit with corrections.
- 7.3. The Company reserves the right to disqualify participants at its sole discretion, without prior notice or explanation.

8. Technical Limitations and Liability

- 8.1. The Company is not liable for technical failures, system errors, or disruptions affecting the Promotion. However, the Company will make reasonable efforts to minimize or prevent such issues.
- 8.2. Manual revalidation of tickets and tasks may occur at the Company's discretion.

9. Amendments, Legal Disclaimers, and Final Provisions

- 9.1. By participating, Clients acknowledge their understanding and acceptance of these Terms and Conditions.
- 9.2. The Promotion is open to Clients who are 18 years of age or older and are legally permitted to trade with Headway in their respective jurisdictions. Clients from jurisdictions where such promotions are restricted or prohibited are not eligible.
- 9.3. Clients are solely responsible for any applicable taxes, fees, or other legal obligations related to receiving a prize.
- 9.4. Force Majeure: The Company shall not be held liable for any delay or failure to perform its obligations under this Promotion due to circumstances beyond its reasonable control, including but not limited to natural disasters, war, government restrictions, or internet outages.
- 9.5. While the Company will make reasonable efforts to deliver prizes, it does not guarantee successful delivery in regions where customs, logistics, or legal restrictions apply. Physical prizes may be substituted with cash equivalents at the Company's discretion.
- 9.6. The Company reserves the right to revoke tickets, bonuses, coins, or prizes at any time if it detects abuse, manipulation, or fraud, even after the Promotion has ended.
- 9.7. The Company reserves the right to:
 - 9.7.1. Modify, suspend, or terminate the Promotion at any time without prior notice.
 - 9.7.2. Close the Promotion at its sole discretion.
 - 9.7.3. Use and publish information related to the Client's account for promotional purposes.
 - 9.7.4. Request the Client to log in to the trading account from an alternative device for additional verification.
 - 9.7.5. Require verification in the Personal Area before awarding any prize.
 - 9.7.6. The Company's decision is final and not subject to appeal.
