

World Cup Score Predictions

Terms & Conditions

1. General

1.1 Traders Trust Ltd (hereinafter "Traders Trust", "TTCM" and "the Company") is a company incorporated under the Laws of Seychelles with Registration Number 8429440-1 and having its registered address at CT House, Office 9A, Providence, Mahe, Seychelles. It is authorized and regulated by the Financial Services Authority ("FSA") as a Securities Dealer, holder of Securities Dealer Licence SD141.

1.2 TTCM Traders Capital Limited (hereinafter "Traders Trust", "TTCM" and "the Company") is a limited liability company incorporated in Bermuda under Sections 14 and 6/132C(1) of the Companies Act 1981, registered under Company Number 54135 and having its registered address at 5th Floor, Andrew's Place, 51 Church Street, Hamilton HM 12, Bermuda.

1.3 These World Cup Score Predictions Terms & Conditions ("Terms") govern participation in the World Cup Score Predictions Competition ("Competition") organized by the Company.

1.4 Registration for, or participation in, the Competition constitutes full acceptance of these Terms.

1.5 The Competition consists of six independent prediction rounds corresponding to the World Cup tournament stages. Points reset at the beginning of each Competition round.

1.6 The applicable Competition schedule, prizes, and any promotion-specific information shall be published on the official Competition landing page.

2. Eligibility

2.1 Participation is open only to Traders Trust clients.

2.2 Only persons who are at least eighteen (18) years of age, or the legal age of majority in their country of residence, may participate.

2.3 Participation in the Competition is free of charge.

3. Competition Rules

3.1 Participants must submit their predictions for each eligible match through the official Competition webpage before the scheduled kick-off time.

3.2 Participants may create, modify, or update their predictions at any time before the match begins. Once the official kick-off time has been reached, predictions shall automatically lock and cannot be amended.

3.3 Match kick-off times displayed on the Competition platform are automatically converted to the participant's local time zone.

3.4 Points shall be awarded as follows:

- a) Three (3) points for correctly predicting the exact final score of a match.
- b) One (1) point for correctly predicting the match outcome (win/loss/draw) without correctly predicting the exact final score.
- c) Zero (0) points for an incorrect prediction.

3.5 To be eligible to receive a prize in any Competition round, a participant must correctly predict the exact final score of at least one (1) match during that Competition round.

- Final (19 July): One (1) winner receives a USD 100 No Deposit Bonus.

4.3 Use of the No Deposit Bonus account shall be governed by the Company's No Deposit Bonus General Terms & Conditions, as amended from time to time.
